TO ALL PLAN HOLDERS OF RECORD:

THE FOLLOWING INFORMATION AND ATTACHMENT IS NECESSARY TO PROPERLY PREPARE BIDS:

Firms submitting bids for the above bid shall take note of the following changes, additions, deletions, clarifications, etc. in the Bid Documents, which shall become part of and have precedence over anything contrarily shown or described in the Bid Documents, all such shall be taken into consideration and be included in the bidder's bid.

GENERAL:

This document comprises **Addendum No. 1** to the above referenced project and shall be part of the Contract Documents and must be acknowledged on the proper bid form page and submitted with bid. Instructions below shall supersede any contradictory instructions in the Contract Bid Documents.

The following is a summary of written questions received and response:

1. QUESTION: On requirement around the desire for a three year contract? From the submission documents, it appears that a specific price quote is required for each individual year, for three years, under the Life and Add policy. However, the property and casualty lines appear to only require a specific price quote for Year 1. Is this correct? Are you seeking a specific price for out years on the P&C lines, some general parameters to pricing the out years, such as inflation guards, or is there no direct requirement around these out years?

ANSWER: The Life and ADD is a three year policy, with annual adjustments, depending on loss experience.

The property and casualty insurance is an annual quotation, with the 2nd and 3rd year premiums subject to change, depending on the loss experience.

2. QUESTION: Does the Lynn Water and Sewer have a list of current drivers for the Auto policy.

ANSWER. Yes, please see pages 2 and 3 for the list of current drivers.
